Company Profile

PT AKR Corporindo Tbk (the "Company") was established in Surabaya on November 28, 1977, based on the Notarial Deed No. 46 of Sastra Kosasih, S.H.

As stated in Article 3 of the Company's Articles of Association, its scope of activities comprises of chemical industry, general trading of primarily chemical products and distribution and trading of petroleum products and gas, engaging in the logistics business, transportation (including for own use and for transport operations by land or sea and operations of side piping infrastructure), rental of warehouses and storage tanks including workshop, expedition and packaging, acting as a representative and/or an agent, with distributorship agreements with foreign and local manufacturers, contractors and other services except legal services.

The Company has an operational track record of more than 40 years and is one of the largest distributors of basic chemicals to industrial customers in Indonesia. Through its subsidiaries, the Company is one of the largest manufacturers of Sorbitol and other starch sweeteners with manufacturing operations in Indonesia and China. The Company is one of the first movers in the distribution of refined petroleum products in Indonesia.

The Company has traded and distributed basic chemicals, which are the raw materials used in a variety of industries, such as chloro-alkali chemicals, solvents, and organic and inorganic chemicals, to industrial customers in Indonesia. The Company represents international basic chemicals manufacturers and acts as their principal distributor in Indonesia

The Company pioneered the building of tank terminals in major ports in Indonesia, for handling bulk chemicals and now operates in nine major sea ports in Indonesia. In 2006, the Company commenced the operation of ports facilities in China.

Since October 2005, the Company distributes non subsidized petroleum products utilizing its existing logistics infrastructure to the mining, power, bunker and commercial sectors in Indonesia. In 2010, the Indonesian Government opened the subsidized fuel sector to the private sector and the Company was the first Indonesian private sector company to be awarded the rights to distribute subsidized fuels.

The Company provides a comprehensive supply chain, logistics solution to domestic third party customers iwith its investment in modern port handling facilities principally in Java, where it owns 5 harbour mobile cranes, 27 warehouses and more than 200 trucks, In China, the Company owns and operates 5 river ports along the Pearl River in Guigang City, Guangxi Province, principally used for the trans-shipment of containers and bulk products, including coal, sugar, steel and cement.

The Company, through a 51% joint venture with Royal Vopak, of the Netherlands, is currently in the process of commissioning an independent 450,000 Kilolitre private sector petroleum terminal in Tanjung Priok Port, Jakarta, Indonesia,

The Company is domiciled at Wisma AKR, 7 - 8 Floor. JI. Panjang No. 5, Kebon Jeruk, Jakarta. Its major branch office is located at JI. Sumatra No. 51 - 53, Surabaya. Other sales offices are located in Semarang, Bandung, Medan, Lampung, Balikpapan, Pontianak, Banjarmasin, Bali and Makassar. The Company also has a representative office in Guigang, China.

The Company has ownership in subsidiaries: PT. Sorini Agro Asia Corporindo Tbk (SOBI), PT Saritanam Pratama, Khalista (Lizhou) Chemical Industries Ltd, PT. Jakarta Tank Terminal, PT Arjuna Utama Kimia, PT Usaha Era Pratama Nusantara, PT Andahanesa Abadi, PT Anugrah Karya Raya, AKR Guigang Guangxi Contrainer Port, AKR Guigang Port Co Ltd, AKR Guigang Transshipment Port Co Ltd and AKR Guigang Coal Trading Co Ltd.




